10. What rights do you have in relation to the research?

In connection with the research "Sociocultural aspects of acculturation and gender roles among foreign medical students", you have the following rights:

- 1. Right to information you can request information about the processing of your personal data.
- 2. Right of access you can access the personal data we handle.
- 3. Right to rectification if you notice inaccuracies in the personal data we process, you have the right to request rectification.
- 4. Right of erasure if the data processing is based on voluntary consent and there is no other legal basis for the data processing.
- 5. Right to a remedy in the event of a breach of these rights, you have the right to seek legal redress.
